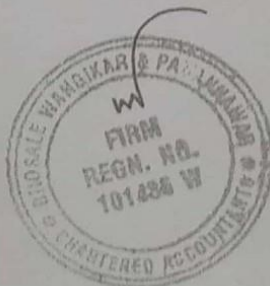


1. We report that-


